## **Council of Extension Organizations – Part of ECOP prior to 1964**

**1964** – Ad Hoc committee on Agents Association activities recommends that one committee be appointed to represent all association.

Committee structure:

- 1 Director from the state represented by the president of County Agricultural Agents
- 1 Director from the state represented by the vice president of County Agricultural Agents
- 1 Director from the National Association of Home Demonstration Agents
- 1 Director from the 4-H Club Agents Association
- 1 State Leader, HE, or Assistant Director
- 1 State Youth Leader
- 1 ES-USDA representative
- 1 ECOP representative

**1965** – ECOP establishes the “ECOP Subcommittee on Agent’s Associations” and abolishes the Council of Extension Organizations.

**1966** – The ECOP Subcommittee appoints the representatives:

3 county agent associations with 2 reps from each – NACAA, NAEHE (formally the National Association of Home Demonstration Agents) and NAE4-HA (formally the 4-H Club Agents Association) serving a staggered 3 year term (nominated by the associations and approved by ECOP)

2 state directors (1 appointed by ECOP and the other from the state in which one of the national association presidents is located)

1 Federal Extension Representative

**1969** – Study completed on the “Evaluation and Purposes and Effectiveness of State and Local Extension Agent Associations.” Hard copy of this report is in JCEP historical files.

**1970** – Subcommittee expanded to include the president and president-elect of each of the 3 Agent Associations so that each association has 3 representatives.

**1971** – Held concurrent meetings in the South and West of the directors of the 3 member associations on a regional basis. Special emphasis at these meetings was to inform the State Directors of the value of the association annual meetings and the professional development that occurs at each meeting.
